

**Swimming Pool
Policy Resolution 15**

The duly elected Board of Directors of The Woods at Polaris Condominium Association establishes the following for the use of the swimming pool:

1. Pool and pool areas are available only to permanent residents/ owners and their guests. A resident or owner must accompany all guests. Hosts are responsible for guest behavior and damages, as well as, their own. Everyone in the pool area is required to have a wrist band and anyone without one shall be asked to leave. There will be a \$5.00 charge for any lost wristbands that have to be replaced.
2. Unless otherwise posted, the pool is open, from 9 a.m. to 9 p.m., for 16 weeks beginning the Saturday before Memorial Day.
3. All persons using pool do so at their own risk. No one should swim without a capable swimmer present.
4. No one under fourteen (14) years of age shall be permitted in or around the pool area without an adult resident/owner willing to assume responsibility present.
5. Guests are limited to four (4) per unit.
6. Smoking is not permitted in the pool or patio areas.
7. Swimming garments sold, as swimwear, must be worn. Incontinent individuals must wear waterproof swim diapers.
8. Wet swimwear is not permitted inside the party room.
9. Dry off prior to using restrooms in the Clubhouse.
10. Running, excessive splashing and excessive noise are not permitted.
11. No diving is permitted.
12. Flotation devices are not permitted unless they are required for personal safety. Individuals requiring a flotation device must be accompanied by and closely supervised by a responsible adult at all times. Water aerobic flotation devices are permitted during water aerobics classes.
13. All radios must be kept at a volume level low enough to avoid being a nuisance to others.
14. No pets in the pool area.
15. No private parties
16. Glass containers are not permitted in the pool or patio areas.
17. All food and drink must be confined to the patio area.
18. Keep the restroom area clean and neat and report any supplies needed to the Property Manager.




